  - (1) Represents 1,296 shares of restricted Class A Common Stock received by the Reporting Person pursuant to a dividend reinvestment feature under the Issuer's 2000 Stock Incentive Plan. Such acquisition is exempt from Section 16 reporting requirements pursuant to Rule 16a-11.
  - (2) On October 15, 2006, 44,890.1445 shares of restricted Class A Common Stock vested. The award of these restricted shares to the Reporting Person has previously been reported.
