The Registrant in November 2002, filed for bankruptcy protection. As a result, its operations and available staff have been severely reduced. The Registrant was unable to complete analysis of all financial and non-financial information needed to be included in the report. As a result, the Registrant's independent auditors will also not be able to complete their review of the financial statements prior to March 31, 2003.
