Item 5. Other Events.

On November 19, 2001, The ServiceMaster Company, a Delaware corporation (the "Company"), announced that the Court of Appeals of Georgia reversed the trial court's decision in the case of Ray D. Martin v. ServiceMaster. The Court of Appeals held that Mr. Martin's claim should have been limited to breach of his employment contract. The Court of Appeals remanded the case back to the trial court for a new trial, noting that Mr. Martin was not entitled to punitive damages and that the Company's motion to dismiss the tort claims should have been granted.
