- (2) Pursuant to a reorganization exempt under Rule 16b-7, each outstanding option to purchase a share of Home Federal Bancorp, Inc. of Louisiana common stock as of December 22, 2010 was automatically exchanged for an option for 0.9110 shares of the Issuer with the exercise price adjusted by a proportional amount. The options vested at a rate of 20% per year commencing on August 18, 2006.
