(1) No shares were sold- these shares were withheld by the Issuer to satisfy tax withholding requirements in connection with the vesting of 6,267 restricted stock units and 125,645 restricted stock units granted to the reporting person on 12/15/2013 and 5,731 restricted stock units granted to the reporting person on 04/01/2016.

(2) Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock.

(3) The reporting person received restricted stock units subject to a four-year vesting schedule, vesting 25% on 12/15/14 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
