The Company expects that its earnings, when reported, will reflect a loss for the fourth quarter and for the year ended December 31, 2004. Management currently estimates that the net loss for 2004 will exceed \$2 million, but will be less than \$3 million (\$(0.17) to \$(0.25) per share). The loss will result, in large part, from recognition of impairment to the carrying amount of goodwill associated with the Company s Foresight subsidiary, a non-core business, as well as from impairment of capitalized software cost and providing allowances for uncollectible receivables and notes.
