As previously announced in the Company s Form 8-K filed April 26, 2005, the Audit Committee of the Company s Board of Directors concluded that certain previously issued financial statements would need to be restated to correct the accounting for our deferred compensation plan. The decision to delay filing of the Form 10-Q was made in light of the Company s intention to restate its previously issued financial statements.
