**MTS Announces Subscriber Growth Numbers for January 2006**

**Moscow, Russian Federation February 16, 2006 Mobile TeleSystems OJSC ( MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 59.50 million users on January 31, 2006.**

During January 2006, MTS consolidated subscriber base increased by 1.31 million subscribers, of which 0.66 million were added in Russia.
