**Item 7.01 Regulation FD Disclosure.**

On September 19, 2006, INVESTTools Inc. (the Company) and thinkorswim Group Inc. announced that the two parties had entered into a definitive merger agreement to combine the two companies in a transaction valued at approximately \$340 million. On September 19, 2006, a conference call was held at 9:00 a.m. Eastern to discuss the proposed transaction, during which time a presentation was reviewed. The Company is hereby furnishing the presentation, which information is posted on the Company's corporate website under the Investor Relations section. Such information is furnished as Exhibit 99.1 to this Current Report on Form 8-K. The information in Item 7.01 of this Current Report on Form 8-K, including the exhibit, shall not be deemed filed for purposes of Section 18 of the Exchange Act, or incorporated by reference in any filing under the Securities Act or the Exchange Act, except as shall be expressly set forth by specific reference in such a filing.

In connection with the solicitation of proxies from the shareholders of INVESTTools to, among other things, approve the issuance of INVESTTools common stock in connection with the proposed merger, INVESTTools will file a proxy statement with the Securities and Exchange Commission (the SEC). Investors and security holders are advised to read the proxy statement when it becomes available because it will contain important information about the merger and the parties to the merger.
