Any shares of Class A common stock, Class B common stock and Class C common stock outstanding on May 31, 2015 will automatically convert into shares of Class P common stock.
 - (2) The Reporting Person disclaims beneficial ownership of the shares owned by his spouse, and his report shall not be deemed an admission that the Reporting Person is the beneficial owner of such shares.
 - (3) The Reporting Person transferred 13,333,333 shares to a limited partnership and disclaims 99% of any beneficial ownership of the shares owned by the limited partnership.
