(1) As described in the Issuer's Registration Statement on Form S-1, as amended (File No. 333-172186), including the Redemption Agreement filed as an exhibit thereto, common units were redeemed by the Issuer from pre-IPO unitholders on a pro-rata basis in connection with the exercise by the underwriters of their option to purchase additional common units from the Issuer in excess of 350,000 common units.

(2) These units are owned directly by NGL Holdings, Inc. NGL Holdings, Inc. is 100% owned by Denham Commodity Partners Fund II LP, which is managed by its general partner, Denham Commodity Partners GP II LP, which is owned by the employees of Denham Capital Management LP and is controlled by its general partner, Denham GP II LLC, which is in turn owned by Stuart D. Porter. Denham Capital Management LP, of which Stuart D. Porter is Chairman and CEO, acts as the investment advisor for Denham Commodity Partners Fund II LP. Each of the Reporting Persons disclaims beneficial ownership of these securities except to the extent of their pecuniary interest therein, and the inclusion of these securities in this report shall not be deemed an admission of beneficial ownership of all of the reported securities for purposes of Section 16 or any other purpose.
