On May 14, 2012 in accordance with Italian law, the requisite Italian Internal Dealing forms were filed with Borsa Italiana and CONSOB to disclose the transactions described below. On May 10, 2012, Delfin S.à r.l. sold 300,000 ordinary shares of the Company to Luigi Francavilla pursuant to a grant made to him under the Delfin Plan at a strike price of Euro 13.67 per share for a purchase price of Euro 4,101,000. On the same date Delfin S.à r.l. acquired 300,000 ordinary shares of the Company from Mr. Francavilla in an off-market transaction at a price per share of Euro 27.43.

On May 11, 2012, Delfin S.à r.l. sold 300,000 ordinary shares of the Company to Mr. Francavilla pursuant to a grant made to him under the Delfin Plan at a strike price of Euro 13.67 per share for a purchase price of Euro 4,101,000. On the same date Delfin S.à r.l. acquired 300,000 ordinary shares of the Company from Mr. Francavilla in an off-market transaction at a price per share of Euro 27.23.
