**Item 5.07. Submission of Matters to a Vote of Security Holders.**

Streamline Health Solutions, Inc. (the "Company") held its Annual Meeting of Stockholders on May 25, 2016. Proxies for the meeting were solicited pursuant to Section 14(a) of the Securities Exchange Act of 1934, as amended, and there was no solicitation in opposition to the Board of Directors' solicitation. At the Annual Meeting, the Company's stockholders voted upon three proposals. The proposals are described in detail in the Company's Proxy Statement. A brief description and the final vote results for each proposal follow. With respect to all proposals, the Company's shares of common stock and preferred stock voted together as a single class.

## 1. Election of six directors for terms expiring at the 2017 Annual Meeting of Stockholders:
