Until the occurrence of certain prescribed events, the Rights are not exercisable, are evidenced by the certificates for Applera Applied Biosystems Stock, and will be transferred along with and only with such securities. Thereafter, separate Rights certificates will be issued representing one Right for each share of Applera Applied Biosystems Stock held, subject to adjustment pursuant to anti-dilution provisions.
