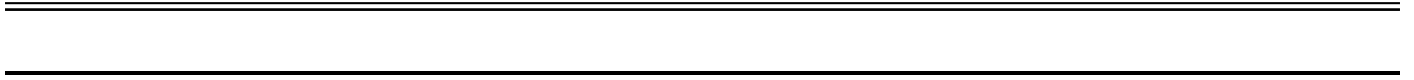

Thereafter, separate Rights certificates will be issued representing one Right for each share of Applera  Applied Biosystems Stock held, subject to adjustment pursuant to anti-dilution provisions.
