Phantom stock units acquired pursuant to a deferred compensation agreement between reporting person and Company and/or increases to the Director's phantom stock credits under the Deferred Compensation Plan for nonemployee Directors due to deemed reinvestments of (1) hypothetical dividends thereunder. Payment of the number of shares credited to the account occurs upon the Director's departure from the Board.
