On January 27, 2017, the reporting person was granted restricted stock units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company"), subject to vesting conditions, to vest in one-third increments on January 27, 2018, 2019 and 2020. On January 27, 2019, 9,945 shares vested in connection with these RSUs, of which 2,681 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.

On January 27, 2019, the transfer restrictions lapsed in connection with 3,945 of these RSUs, of which 1,064 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
