Peace Arch Is Dismissed From Comerica Bank Litigation

TORONTO, ONT. Peace Arch Entertainment Group Inc. (AMEX and TSX: PAE), today announced that the Company has been dismissed from the action that was initiated in June 2004 in Los Angeles, California against them and others by Comerica Bank (Comerica).

Comerica has named numerous additional parties in connection with complaints that date back approximately five years in which Peace Arch Entertainment Group Inc. was not involved, and which matters have been the subject of prior litigation efforts by Comerica against unrelated parties.
