- (1) Mr. Kennedy did not sell any of the 10,538 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/2/11 vesting of 27,834 of the 83,500 shares of restricted stock Mr. Kennedy was granted on 12/10/07. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of these 132,160 shares reflected as beneficially owned, (a) 56,167 shares are unvested restricted shares that the reporting person was granted on 12/8/08 which vest in substantially equal installments on 1/10/11 and 1/10/12; and (b) 20,000 shares are shares held in the reporting person's account under the Revlon Employees' Savings, Investment and Profit Sharing Plan.
