(1) Mr. Bashinsky's Estate/Trusts, votes the shares of Issuer's stock owned by the Marital Trust created by the Last Will and Testament of Mr. Bashinsky ("Testamentary Trust") (1,600,279 Shares) and the shares owned by SYB, Inc. (5,231,128 Shares). Mrs. Bashinsky disclaims beneficial ownership of such Shares. The Voting Committee has previously executed a Schedule 13D on behalf of a Voting Group of the Testamentary Trust and the SYB, Inc. Common Stock Trust.
