- (1) On May 26, 2017, a two-for-one stock split of the Common Stock of Silgan Holdings Inc. in the form of a stock dividend was effected, resulting in the reporting person's direct ownership of 18,891 additional shares of Common Stock of Silgan Holdings Inc. on such date (including 8,720 additional restricted stock units).
- These securities are restricted stock units that were granted on March 1, 2018 under the Silgan Holdings Inc. Amended and Restated 2004
