Item 1. Security and Issuer

This statement on Schedule 13D (this "Schedule 13D") relates to the common stock, par value \$.001 per share (the "Common Stock"), of Conversion Services International, Inc., a Delaware corporation (the "Issuer"). The address of the principal executive offices of the Issuer is 100 Eagle Rock Avenue, East Hanover, New Jersey 07936.

Item 2. Identity and Background

(a) This Schedule 13D is being filed by Glenn Peipert (the "Reporting Person" or "Mr. Peipert").

(b) Mr. Peipert's business address is Conversion Services International, Inc., 100 Eagle Rock Avenue, East Hanover, New Jersey 07936.

(c) Mr. Peipert's present principal occupation is as Senior Vice President

and Chief Operating Officer of the Issuer.

(d), (e) During the past five (5) years, Mr. Peipert has not (i) been convicted in a criminal proceeding or (ii) been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) Mr. Peipert is a citizen of the United States of America.

Item 3. Source and Amount of Funds or Other Consideration

On January 30, 2004, the Reporting Person became the beneficial owner of 150,000,000 shares of Common Stock as a result of the closing of the merger contemplated by the Agreement and Plan of Reorganization dated as of August 21, 2003, as amended, by and among Conversion Services International, Inc., then a privately-held Delaware corporation ("Old CSI"), the Issuer and LCS Acquisition Corp., a direct, wholly owned subsidiary of the Issuer. As part of the transaction, the Issuer changed its name to "Conversion Services International, Inc." and the former stockholders of Old CSI obtained approximately 84.3% of the outstanding Common Stock of the Issuer.

Item 4. Purpose of Transaction

Except as set forth in Item 5 hereof, the Reporting Person has no present plan or proposal that relates to or would result in any matters referred to in paragraphs (a) through (j) of Item 4 of Schedule 13D. However, the Reporting Person reserves the right to formulate plans or proposals specified in paragraphs (a) through (j) of Item 4 of Schedule 13D.

Item 5. Interest in Securities of the Issuer

(a), (b) The Reporting Person beneficially owns 150,000,000 shares of Common Stock or 25.3% of the outstanding shares of Common Stock entitled to vote. The Reporting Person has sole voting power of all the shares of Common Stock he beneficially owns.

(c) The following table set forth a description of all transactions in shares of Common Stock of the Issuer by the Reporting Person identified in Item 2 of this Schedule 13D effected during the past sixty days.
