The Registrant expects to report approximately \$12.4 million of revenues for the year ended December 31, 2009, compared to revenues of approximately \$4.9 million for fiscal 2008. The Registrant expects to report approximately \$12.7 million of total expenses in fiscal 2009 compared to approximately \$9.7 million in fiscal 2008. The Registrant also expects to report a net loss for the year ended December 31, 2009 of approximately \$300,000, or \$0.02 per diluted share, as compared to a net loss for 2008 of approximately \$4.8 million, or \$0.42 per diluted share. The results of operations stated above are only preliminary estimates and should not be relied upon as the actual results of operations.
