As of the date of this filing, Leroy Scott Frantz (the "Reporting Person") is the beneficial owner of an aggregate of 637,622 shares of cumulative term preferred shares, par \$0.01 per share (the "Preferred Stock"), of Oxford Lane Capital Corp. ("OXLC"). The Preferred Stock of OXLC is comprised of three series: (i) Cumulative Term Preferred Shares, 8.50% Series 2017 Term Preferred Shares; (ii) Cumulative Term Preferred Shares, 7.50% Series 2023 Term Preferred Shares"); and (iii) Cumulative Term Preferred Shares, 8.125% Series 2024 Term Preferred Shares (the "Series 2024 Term Preferred Shares"). The Reporting Person owns 437,622 shares of the Series 2023 Term Preferred Shares and 200,000 shares of the Series 2024 Term Preferred Shares. Collectively, the Reporting Person's beneficial ownership of 637,622 shares of Preferred Stock constitutes approximately 10.6% of OXLC's outstanding shares of Preferred Stock, based upon 6,014,720 shares of Preferred Stock outstanding as of December 31, 2014. The Reporting Person owns directly, and has sole power to vote and dispose of all 637,622 shares of Preferred Stock.
