 - (2) The Reporting Person is the direct beneficial owner of 516,508 shares of common stock of the Issuer, excluding 142.92 shares of common stock of the Issuer held in the Issuer's 401(k) plan. - (3) Each restricted stock unit represents a contingent right to receive one share of Common Stock.

- On May 11, 2009, the restricted stock units were granted with vesting in four equal installments over a four year period. As of the date of this filing, 26,000 of the restricted stock units have vested and 0 restricted stock units remain unvested. Shares of the Issuer's common stock will be delivered to the reporting person as soon as administratively practicable following the vesting of the restricted stock units.
