- (1) Mr. Mammone did not sell any of the 667 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of federal and state withholding taxes due upon the 1/2/09 vesting of 1,666 of the 5,000 shares of restricted stock Mr. Mammone was granted on 12/10/07 (as adjusted for Revlon, Inc.'s September 2008 1-for-10 reverse stock split). These 667 withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- Of these 14,579 shares reflected as beneficially owned, (a) 583 shares are unvested restricted shares that the reporting person was granted on 11/16/06, which vest on 11/16/09, (b) 3,334 shares are unvested restricted shares that the reporting person was granted on 12/10/07, (2) 1,667 shares of which vest on 1/2/10 and 1,667 shares of which vest on 1/2/11, and (c) 5,500 shares are unvested restricted shares that the reporting person was granted on 12/8/08, 1,883 shares of which vest on 1/10/10, 1,883 shares of which vest on 1/10/11 and 1,834 shares of which vest on 1/10/12 (in each case as adjusted for Revlon, Inc.'s September 2008 1-for-10 reverse stock split).
