## **Section 5 - Corporate Governance and Management**

### **Item 5.02 - Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers**

On April 24, 2013 BioTime’s Chief Financial Officer, Peter S. Garcia, resigned his position with the Company effective May 10, 2013. Mr. Garcia is leaving BioTime on an amicable basis to become the chief financial officer of a larger public company located in another state.

BioTime’s Senior Vice President and Chief Operating Officer, Robert W. Peabody, will reassume the additional role as Chief Financial Officer commencing May 10, 2013. Mr. Peabody, 58, has served as our Senior Vice-President and Chief Operating Officer since 2007 and also served on an interim basis as our Chief Financial Officer from September 2010 until October 2011. Prior to joining BioTime in October 2007, Mr. Peabody served as a Vice-President of Advanced Cell Technology, Inc., and also served on their board of directors from 1998 to 2006. Prior to joining ACT, Mr. Peabody spent 14 years as a Regional Controller for Ecolab, Inc., a Fortune 500 specialty chemical manufacturer and service company. He has also been an audit manager for Ernst and Young where he was a Certified Public Accountant on the audit staff serving the firm’s clients whose shares are publicly traded. Mr. Peabody received a Bachelor Degree in Business Administration from the University of Michigan.
