ROSH HA'AYIN, Israel, July 26, 2010 - Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announces that Standard & Poor's Maalot ("S&P Maalot") has reaffirmed today the company's 'iAA-' credit rating with a stable outlook, despite the increased regulatory pressures.

In its report, S&P Maalot stated, inter alia, that: "the stable outlook reflects our view that we are unlikely to lower Partner's rating as long as its stand-alone leverage<sup>1</sup> remains below 2.5x and that any decline in profitability is contained."

Scailex's shares are traded on the Tel Aviv Stock Exchange under the symbol SCIX and are quoted on "Pink Quote" under the symbol SCIXF.PK. Scailex currently operates in two major domains of activity in addition to its holding in Partner (after selling "Dynamic", a chain of retail stores and booths to Cellcom on April 1, 2010) : (1) the sole import, distribution and maintenance of Samsung mobile handset and accessories products primarily to the major cellular operators in Israel (2) management of its financial assets.
