On August 9, 2005, IAC completed the spin-off of Expedia, distributing all of its shares of Expedia Common Stock and all of its shares of Expedia Class B Common Stock to holders of IAC Common Stock and IAC Class B Common Stock, respectively, on a share for share basis.
