The rights to convert LTIP Units into Common Units and redeem Common Units do not have expiration dates.
- (5) 17,174 LTIP Units earned pursuant to the Plan vest 50% on January 1, 2013, 25% on January 1, 2014 and 25% on January 1, 2015 and the remaining 3,000 LTIP units are not subject to vesting.
