- (1) Shares surrendered to pay tax liability due at vesting of Performance Shares.

- (3) This transaction was executed in multiple trades at prices ranging from \$58.25 to \$58.65. The price reported above reflects the weighted average sales price. - (5) RSU award granted on January 24, 2012 vests at a rate of 25% annually on the first, second, third and fourth anniversaries of the grant date. The remaining units will vest on January 24, 2015 as to 13,750 shares and January 24, 2016 as to the remaining 13,750 shares.

The participant earned 130% of the target award based on the achievement of certain pre-established performance goals during the 2011 fiscal year. - (7) RSU award granted on January 24, 2011 vests at a rate of 25% annually on the first, second, third and fourth anniversaries of the grant date. The remaining units will vest on January 24, 2015 as to the remaining 6,750 shares.
- (8) Vests at a rate of 50% annually on the first and second anniversaries of the January 24, 2013 grant date. The remaining units will vest on January 24, 2015 as to the remaining 23,750 shares.

RSU award granted on January 25, 2010 vests at a rate of 25% annually on the first, second, third and fourth anniversaries of the grant date. This Restricted Stock Unit award vested in full on January 25, 2014.

Each Performance Share represents a contingent right to receive one share of ADBE common stock. The maximum number represents 200% of the target payout of 31,650 shares.
