 (1) Effective February 1, 2016, the Reporting Person, Mr. Jay Sugarman, acquired 21,714 shares of iStar Common Stock upon the vesting of Restricted Stock Units pursuant to an incentive equity award granted February 1, 2013, which award was previously reported on Form 4. After deducting 9,065 shares of iStar Common Stock for applicable tax withholdings, the Reporting Person acquired a net amount of 12,649 shares of iStar Common Stock.  
 (2) Following the transactions reported in this Form 4, the Reporting Person is the direct beneficial owner of 2,560,336 shares of iStar Common Stock and 2,000 shares of iStar Series D Preferred Stock and the indirect beneficial owner of 40,544 shares of iStar Common Stock owned by his spouse.
