- (1) The total includes the acquisition of 3,3481 shares at \$46.630 per share received on 10/07/09 through dividends paid in shares.
- (2) There is no reportable change since the last filing. This is a reiteration of holdings only.
- (3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(4) As previously reported, on 01/15/09 the Reporting Person was granted 19,690 restricted stock units ("RSUs"), 9,845 of which will vest on each of 01/15/10 and 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 33,8316 dividend equivalent rights being reported reflect 33,8316 dividend equivalent rights at \$45.96 per RSU credited to the Reporting Person's account on 10/07/09.

(5) On 12/10/09 the Reporting Person was granted 18,061 restricted stock units ("RSUs"), 9,030 of which will vest on 12/10/10 and 9,031 of which will vest on 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP
