(1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(2) As previously reported, on 01/18/12 the reporting person was granted 50,000 restricted stock units ("RSUs"), 16,666 of which vested on 01/18/13, and 16,667 of which will vest on each of 01/18/14 and 01/18/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 226,172 dividend equivalent rights being reported reflect 226,172 dividend equivalent rights at \$21.40 per RSU credited to the reporting person's account on 10/02/13.

(3) As previously reported, on 12/06/12 the reporting person was granted 40,000 restricted stock units ("RSUs"), 13,333 of which vested on 12/06/13, 13,333 of which will vest on 12/06/14, and 13,334 of which will vest on 12/06/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned immediately prior to the transaction being reported includes 271,401 dividend equivalent rights at \$21.40 per RSU credited to the reporting person's account on 10/02/13. The number of derivative securities in column 5 includes 366 vested dividend equivalent rights and a de minimus adjustment of 0.4216 due to fractional rounding of the dividend equivalent rights.
