On September 13, 2005, we entered into a Third Amendment to our \$1.0 billion five-year credit agreement ("Credit Agreement") with Bank of America, N.A., as Administrative Agent for the Lenders and as a Lender and L/C Issuer, and the Lenders. The Credit Agreement was originally effective on September 17, 2004.

The Third Amendment to the Credit Agreement increases the Lenders' aggregate commitments and our borrowing capacity by \$200 million, from \$1.0 billion to \$1.2 billion.
