Vested RSUs will be paid in shares of the Company's common stock on a one-to-one basis shortly following vesting unless payments is otherwise deferred by the directors to a date elected by the director.

Director Equity Incentive Program under the Company's Amended and Restated 1991 Equity Incentive Plan, which were paid in shares of the Company's common stock on a one-to-one basis shortly after vesting and which were previously identified as Restricted Stock Units on Table 1.
