- (1) 2000 Stock Incentive Plan - This option vests in four equal installments beginning on 6-27-03  
2000 Stock Incentive Plan: These restricted shares were awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan. Amount includes 1575 restricted shares that vest in four equal annual installments beginning on April 15, 2005, 2982 restricted shares that will vest effective December 2, 2007 and 7183 restricted shares that will vest effective December 1, 2008. Total amount includes shares acquired pursuant to a dividend reinvestment feature of the Plan.
- (2) 2000 Stock Incentive Plan: This option vests in four equal installments beginning on December 9, 2003.
- (3) 2000 Stock Incentive Plan: This option vests in four equal installment beginning on December 3, 2004.
- (4) 2000 Stock Incentive Plan: This option vests in four equal installments beginning on December 2, 2005.
- (5) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.
- (6) Deferred Compensation Plan: These units convert into shares of common stock on a 1-for-1 basis.
