**(1)** Mr. Martin was awarded 3,441 Restricted Stock Units. Each Restricted Stock Unit represents a contingent right to receive one share of Conn's, Inc Common Stock. The Restricted Stock Units vest on May 30, 2013. Vested common stock shares will be delivered to the reporting person within thirty days following the date of the vesting of the shares. The Restricted Stock Units may be settled only by delivering of shares of Conn's Inc Common Stock, and thus, the grant is being reported on table I as allowed by SEC guidance.
