- (1) New Enterprise Associates 10, Limited Partnership ("NEA 10") made a pro rata distribution for no consideration of an aggregate of 1,000,000 shares of Common Stock of the Issuer to its general partner and its limited partners on December 10, 2013.

The Reporting Person disclaims beneficial ownership within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise of such portion of the shares of Common Stock of the Issuer held by NEA 10 in which the Reporting Person has no pecuniary interest.
- (3) NEA Partners 10 received 10,000 shares of Common Stock of the Issuer in the distribution by NEA 10 on December 10, 2013.
- (4) The Reporting Person is a general partner of NEA Partners 10 which is the direct beneficial owner of the shares. The Reporting Person disclaims beneficial ownership within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise of such portion of the shares of Common Stock of the Issuer held by NEA Partners 10 in which the Reporting Person has no pecuniary interest.
- (5) NEA Partners 10 made a pro rata distribution for no consideration of an aggregate of 10,000 shares of Common Stock of the Issuer to its limited partners on December 10, 2013.
- (6) New Enterprise Associates, LLC ("NEA LLC") received 1,452 shares of Common Stock of the Issuer in the distribution by NEA Partners 10 on December 10, 2013.
- (7) The Reporting Person is a member of the Board of Directors of NEA LLC, which is the direct beneficial owner of the shares.
