- (1) On January 27, 2014, Prakash Melwani was granted 2,479 shares of common stock by Crocs, Inc. (the "Issuer") under the Issuer's 2007 Equity Incentive Plan (as amended). Mr. Melwani is an employee of The Blackstone Group L.P. or one of its affiliates ("Blackstone").

Pursuant to arrangements between Mr. Melwani and Blackstone, Mr. Melwani was required to transfer to Blackstone any and all compensation received in connection with his directorship for any company Blackstone invests in or advises. Blackstone has designated Blackstone Management Partners L.L.C. ("BMP") as the entity to receive Mr. Melwani's shares.

- BMP is an indirect subsidiary of The Blackstone Group L.P. The general partner of The Blackstone Group L.P. is Blackstone Group Management L.L.C. Blackstone Group Management L.L.C. is wholly owned by Blackstone's senior managing directors and controlled by its founder, Stephen A. Schwarzman.
- (2) Information with respect to each of the Reporting Persons is given solely by such Reporting Person, and no Reporting Person has responsibility for the accuracy or completeness of information supplied by another Reporting Person.

- Each of such Blackstone entities and Mr. Schwarzman may be deemed to beneficially own the shares beneficially owned by BMP, but each disclaims beneficial ownership of such shares, except to the extent of such Reporting Person's pecuniary interest therein.
