The Registrant expects to report approximately \$4.54 million and \$8.51 million in revenues for the three and six months ended June 30, 2013, respectively, compared to revenues of \$3.73 million and \$7.95 million for the same periods in 2012. Further, the Registrant anticipates reporting net operating losses of \$8,987 and \$136,652 for the three and six months ended June 30, 2013, respectively, as opposed to net operating losses of \$241,080 and \$176,143 for the same quarters of 2012. In addition, the Registrant anticipates reporting total comprehensive income of \$214,331 and \$61,683 for the three and six months ended June 30, 2013, respectively, contrasting to total comprehensive income of \$1,515,472 and \$1,600,778 for the same periods of 2012. However, these results of operations are still under review and subject to change.
