(1) On April 20, 2015, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests on the first anniversary of the date of grant and thereafter as to twenty-five percent (25%) of the granted RSU on each subsequent annual anniversary date of the date of grant, subject to necessary withholding for applicable taxes.

(2) On April 20, 2015, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests on June 30, 2015, and will vest thereafter as to an additional twenty-five percent (25%) of the grant on each of April 20, 2016, April 20, 2017 and April 20, 2018, subject to necessary withholding for applicable taxes.
