Unilever NV announces that on 12 June 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.750 and euro 21.960 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 27,621 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 72,163,718 Unilever NV ordinary shares in treasury, and has 1,642,563,982 Unilever NV ordinary shares in issue (excluding treasury shares).
