Unilever NV announces that on 21 June 2007 it purchased 460,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.910 and euro 22.140 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 9,717 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 75,230,025 Unilever NV ordinary shares in treasury, and has 1,639,497,675 Unilever NV ordinary shares in issue (excluding treasury shares).
