Unilever NV also announces that 69,336 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 100,384,710 Unilever NV ordinary shares in treasury, and has 1,614,342,990 Unilever NV ordinary shares in issue (excluding treasury shares).
