INTRODUCTION

This Amendment No. 1 (this Amendment No. 1) amends and supplements the Tender Offer Statement on Schedule TO (the Schedule TO) filled on May 14, 2008 by NightHawk Radiology Holdings, Inc., a Delaware corporation (the Company). The Schedule TO, as amended by this Amendment No. 1, relates to the offer by the Company to purchase up to 6.211.180 shares of its common stock, par value \$0.001 per share, at a price not greater than \$8.05 nor less than \$7.45 per share, net to the seller in cash, less any applicable withholding taxes and without interest, upon the terms and subject to the conditions set forth in the Offer to Purchase dated May 14,2008 (the Offer to Purchase), an amended copy of which is attached hereto as Exhibit (a)(1)(A), and in the related Letter of Transmittal (the Letter of Transmittal), an amended copy of which is attached to the Schedule TO as Exhibit (a)(1)(B).

This Amendment No. 1 is being filed solely to amend Item 12 Exhibits of the Schedule TO to replace in their entirety the (i) Offer to Purchase, (ii) Letter of Transmittal and (iii) Letter to Clients for use by Brokers, Dealers, Commercial Banks, Trust Companies and Other Nominees that were filed as exhibits (a)(1)(A), (a)(1)(B) and (a)(1)(E) to the Schedule TO, respectively. The amended offer materials filed herewith remove all references to a stockholder s ability to condition the tender of shares on the purchase by the Company of a specified minimum number of shares from such stockholder. Inadvertent references to conditional tenders were included in certain portions of the exhibits as originally filed, although the Letter of Transmittal as originally filed did not contain the means to make conditional tenders. Stockholders do not have the right to so condition the tender of their shares. Except as set forth above, there were no changes to the offer materials. Stockholders may continue to use the original Letter of Transmittal to tender shares of Company common stock to the depository.
