**VIMPELCOM S SHAREHOLDERS RE-ELECT BOARD**

**Moscow and New York (June 10, 2009)** Open Joint Stock Company Vimpel-Communications ( VimpelCom or the Company ) (NYSE: **VIP**), announced that at its Annual General Shareholders Meeting (AGSM) held today in Moscow shareholders approved all agenda items and elected a new Board of Directors. Holders of approximately 80.99% of the Company s shares were represented at the AGSM. The composition of the Board of Directors did not change. Alexey Reznikovich was re-elected as the Chairman of the Board of Directors at a Board meeting held following the AGSM.

The Group companies provide services under the Beeline brand. VimpelCom was the first Russian company to list its shares on the New York Stock Exchange ( NYSE ).
