On May 6, 2010, Entertainment Properties Trust (the Company) issued a press release announcing that it had priced the public offering that was the subject of its May 5, 2010 press release. The offering consists of 3,600,000 newly issued common shares, increased from 3,000,000 newly issued common shares, with a grant to the underwriters of an over-allotment option to purchase an additional 540,000 shares of newly issued common shares, increased from 450,000 newly issued common shares. The Company's press release is attached as Exhibit 99.1 hereto and incorporated herein by reference.
