**Item 1.01 Entry into a Material Definitive Agreement.**

OraSure Technologies, Inc. (the Company) and Comerica Bank (Comerica) are parties to a Loan and Security Agreement, dated as of September 10, 2002, as amended (the Loan Agreement), pursuant to which Comerica has provided the Company with certain credit facilities, including a \$10.0 million advance to fund the expansion of certain Company facilities (the Expansion Advance), which had a maturity date of November 27, 2011. An Eighth Amendment to Loan and Security Agreement, dated as of November 18, 2011, was executed by the Company and Comerica (the Eighth Amendment) in order to make certain changes to the Loan Agreement, including an extension of the maturity date of the Expansion Advance to February 27, 2012. A copy of the Eighth Amendment is attached as Exhibit 10 to this Form 8-K and is incorporated herein by reference.
