## Item 8.01 Other Events.

On October 15, 2013, Berkshire Hathaway Finance Corporation ( BHFC ) issued (i) \$400,000,000 aggregate principal amount of its 0.950% Senior Notes due 2016 (the 0.950% Notes ) and (ii) \$550,000,000 aggregate principal amount of its 2.900% Senior Notes due 2020, (the 2.900% Notes, and together with the 0.950% Notes collectively, the Notes ), under a registration statement on Form S-3 under the Securities Act of 1933, as amended (the Securities Act ), filed with the Securities and Exchange Commission (the Commission ) on January 28, 2013 (Registration No. 333-186257) (the Registration Statement ). The Notes, which will be fully and unconditionally guaranteed by Berkshire Hathaway Inc. ( Berkshire ), were sold pursuant to an underwriting agreement (the Underwriting Agreement ) entered into on October 8, 2013, by and between (a) BHFC and Berkshire and (b) Goldman, Sachs & Co., J.P. Morgan Securities LLC, Merrill Lynch, Pierce, Fenner & Smith Incorporated and Wells Fargo Securities, LLC (collectively, the Underwriters ). The Notes are issued under an Indenture, dated as of February 1, 2010, by and among BHFC, as issuer, Berkshire, as guarantor, and The Bank of New York Mellon Trust Company, N.A., as trustee (the Indenture ), and officers certificates dated as of August 15, 2013 with respect to the 0.950% Notes (the 0.950% Notes Officers Certificate ) and October 15, 2013 with respect to the 2.900% Notes (the 2.900% Notes Officers Certificate, and together with the 0.950% Notes Officers Certificate collectively, the Officers Certificates ).

The relevant terms of the Notes and the Indenture are further described under the caption Description of the Notes and Guarantee in the prospectus supplement, dated October 8, 2013, filed with the Commission by Berkshire on October 9, 2013, pursuant to Rule 424(b)(2) under the Securities Act and in the section entitled Description of the Debt Securities in the base prospectus, dated January 28, 2013, included in the Registration Statement, which descriptions are incorporated herein by reference.

A copy of the Indenture is set forth in Exhibit 4.1 of Berkshire s registration statement on Form S-3 under the Securities Act filed with the Commission on February 1, 2010 (Registration No. 333-164611) and is incorporated herein by reference. A copy of the 0.950% Notes Officers Certificate (including the form of the 0.950% Notes) is set forth in Exhibit 4.2 of Berkshire s current report on Form 8-K filed with the Commission on August 15, 2013 and is incorporated herein by reference. A copy of the 2.900% Notes Officers Certificate (including the form of the 2.900% Notes) is attached hereto as Exhibit 4.3 and is incorporated herein by reference. The descriptions of the Indenture, the Officers Certificates and the Notes in this report are summaries and are qualified in their entirety by the terms of the Indenture, the Officers Certificates and the Notes, respectively.
